I. Mill Hill Update

Discussed the home buyers workshop hosted by UDA this past Saturday and the pros and cons. The workshop was well attended however concern was raised over the lack of discussion about credit repair& the target audience for Mill Hill properties. In the future, would like to include discussion of property history before and after simultaneously with a walking tour.

Project Director Jessie helped put into perspective the overall turnout for the workshop (81 responses via Facebook, 50 acknowledged interest, 40 RSVP, 34 RSVP attended & 6 non-RSVP attended), 2 local news outlets were contacted, 4500 emails sent from art community as well. Cadence represented, not scheduled to speak provided contact information for future events to discuss financials.

Two prospects showed interest in properties; 1 offer was received however later retracted due to restrictions. Board member raised concern, stating the restrictions/covenants may need modifying/revising. It appears to be a reoccurring issue. Specific issues raised: maintenance, rental & resale of property. Board to meet next week to discuss possible changes. Any changes require the authorization of the Land Trust regarding covenants, restrictions, and land.
