## II. DT Walton Development Agreement

#### III. Parking Update (Peth)

Parking Advisory board met; discussed requesting additional residential parking in the Residential Pass Zone for downtown residents. Areas requested (3<sup>rd</sup> Street/Cherry Street Lane/Poplar Street & Poplar Street/3<sup>rd</sup> Street/2<sup>nd</sup> Street Lane). The areas requested would add more spaces while simultaneously minimizing the affects on paid parking. Total number of spaces requested, 12.

Motion to approve 6 additional spaces in the Residential Pass Zone (corner of Poplar Street & Third Street) (Barton)(Crisp)2<sup>nd</sup>.

Electrical issues in the garage have been resolved. Attendant booth in the garage to be removed to deter authorized housing.

Will follow-up with the Regional Commission regarding job descriptions. Continuing to work on personnel manual.
